WHO MAY ENTER: Giveaway is open to legal residents of Canada (excluding the province of Quebec) and the contiguous United States (including the District of Columbia) age eighteen (18) or older at time of entry (collectively referred to hereafter as “you” or “Entrant” or “Entrants”).
